## TERMS AND CONDITIONS

- THE EXHIBITIORS state that they do not have access to another gallery; i.e., "gallery" refers to an enclosed space that is dedicated to the exhibition of THE EXHIBITIORS' works; and a wall in an area that is primarily used for other purposes is not considered a gallery.
- THE EXHIBITIORS commit to having their sitters 'trained' prior to the opening of the exhibition by FGAA members in the operation of the gallery, including its door security and Square terminal.
- 3 THE EXHIBITIORS agree to present artworks that are suitable to be exhibited in a public space accessible to families and children.
- 4 THE EXHIBITIORS will manage the financial arrangements for any sale in the gallery, including use of the Square terminal for bank debit and credit card purchases and the handling of 'cash' sales. The number of these sales and their total value will be reported to the Treasurer of the FGAA in order to meet FGAA requirements to the City of Ottawa.

- 5 THE EXHIBITIORS commit to providing sitters to supervise the gallery for each and every time slot during the exhibition.
- THE EXHIBITIORS agree to pay 15% of the total value of all sales made in the gallery during the exhibition to the Treasurer of the FGAA as a contribution to the Young at Art fund.
- THE EXHIBITIORS will be responsible for ensuring that the gallery is securely locked and the key placed in the lockbox at the close of each sitting.
- 8 THE EXHIBITIORS will be responsible for any damage to the Foyer Gallery.
